Ways to Support

- Will and Living Trust: Include Red Hen Press in your will or trust by indicating a specific
 gift or a percentage of the residue. You can designate that your donation remains
 unrestricted or direct it to a specific program such as our Writing in the Schools program or
 one of our many imprints.
